- **High Priority Data Sets:** Learn how essential datasets have been identified and defined to support use cases, essential for achieving the EGD's objectives.
- **Governance Framework:** Explore the inclusive multi-stakeholder governance scheme, which empowers selected reference use cases and their associated value chains. This governance approach enhances the impact of these use cases within the GDDS ecosystem.
- **Roadmap:** Learn about the strategic plan to accelerate the creation and adoption of the GDDS digital ecosystem. An implementation roadmap aligns with stakeholder priorities, ensuring key resources, architectural considerations, and governance are in sync.
- **Co-Design Approach:** Discover how GREAT has embraced a co-design approach. This method incorporates the input, requirements, validation, and endorsements of stakeholders from diverse domains, ensuring a holistic, cross-sectoral vision for the GDDS.

This session provides a unique opportunity for stakeholders to stay informed about the developments in the Green Deal Data Space and contribute with feedback and potential involvement in future deployment actions.
